1. Introduction

LJP Marketing Limited is committed to protecting your personal information and ensuring your experience with us is as safe and enjoyable as possible. This Cookies Policy should be read in conjunction with our Privacy Policy (which can be read here) and our Terms of Use (which can be read here). Our Cookies Policy explains how and why we use "cookies" within our website, software, or other services.

2. What Are Cookies?

Cookies are small amounts of information in the form of text files sent by websites to computers, mobile phones, or other devices when you visit a website or use a mobile application. Although cookies do identify a user's device, cookies do not personally identify users. Cookies allow companies to do various things, such as: tailoring content, personalizing website visits, and ensuring the security of any online experience. Cookies typically contain the name of the domain from which the cookie has come, the "lifetime" of the cookie, and a randomly generated unique number or other value. Cookies cannot be used to run programs or deliver viruses to your computer. Additionally, mobile devices may use other tracking files which are similar to cookies (for example iOS devices use Apple's 'identifier for advertisers' (IDFA) and Android devices use Google's Android ID). In the context of tracking within Resold, the concept of a cookie will include a mobile device identifier for the purpose of this Cookie Policy. Cookies may come in different formats. Session cookies are temporary cookies that remain in your browser until you leave a website. Persistent cookies remain in your browser for a longer period of time. Third-party cookies are cookies that are loaded onto your browser by third-parties. Third-party cookies are usually a type of persistent cookie and are stored until you delete them or they expire based on the time period set in each cookie.

3. Our Use of Cookies

LJP Marketing Limited uses cookies to distinguish you from other users, including, potentially, mobile device identifies. This helps us to improve LJP Marketing Limited website and provide you with the best user experience possible. Please be aware that cookies may be used on LJP Marketing Limited website whether or not you have created an account or submitted information to us.

We may use the following cookies:

- <u>Strictly Necessary Cookies</u>. These are cookies that are required for the operation of LJP Marketing Limited website, such as to enable you to log into secure areas and access different features.
- <u>Performance Cookies.</u> These cookies recognize and count the number of LJP Marketing Limited users and to track user navigation and LJP Marketing Limited interaction/behavior. This information is used to improve the way LJP Marketing Limited website function.
- <u>Functionality Cookies</u>. These cookies recognize when you return to LJP Marketing Limited website, enable personalized content and recognize and remember your preferences.
- <u>Targeting Cookies</u>. These cookies record your visit to LJP Marketing Limited website, including the individual pages visited and the links followed.
- Third-Party Cookies. Some of the persistent and session cookies used by LJP Marketing Limited website may be set by us, and some are set by third parties who are delivering services on our behalf.

Generally, the strictly necessary cookies and some performance and functionality cookies only last for the duration of your visit to a website or expire when you close out of LJP Marketing Limited website: these are known as 'session cookies'. The functionality cookies and some targeting and performance cookies will last for a longer period of time: these are known as 'persistent cookies.' We use session and persistent cookies for the following reasons:

- Authentication, Personalization, and Security. Cookies help us verify your
 account and device and determine when you are logged in, so we can make it
 easier for you to access LJP Marketing Limited website and to provide the
 appropriate experiences and features. We also use cookies to help prevent
 fraudulent use of login credentials and for security purposes.
- <u>Performance and Analytics.</u> Cookies help us analyze how LJP Marketing
 Limited website is being accessed and used and enable us to track
 performance of LJP Marketing Limited website. For example, we use cookies to
 provide insights regarding LJP Marketing Limited website performance, such as
 page views, conversion rates, device information, visitor IP addresses, and
 referral sites.

4. Third-Party Cookies

When you use LJP Marketing Limited website, you may also receive cookies from third parties. The information collected by such third-party cookies is governed by their privacy policies. We may use third-party cookies for the following reasons:

- To allow our business partners to perform analytics and collect information and serve you advertisements.
- To share information with third parties to gain insights and marketing information based on how you use LJP Marketing Limited website.
- To provide to social networks to better understand how users interact through the Internet.
- To optimize LJP Marketing Limited website.
- To remember your user preferences and logins.

5. Lawful Basis for Cookies Used

We use cookies to ensure that LJP Marketing Limited website functions as intended and to provide you with any services that you may have requested. Additionally, we use cookies based on your consent, where required by law, as stated within the Privacy Policy.

6. Opting out and Blocking Cookies

The cookies we use are designed to optimize your experience using LJP Marketing Limited website. If you do not wish to receive cookies, most online browsers and custom device settings allow you to change your cookie settings. Please note however, that (as with other websites and apps) by blocking or deleting cookies used on LJP Marketing Limited website you may not be able to take full advantage of London Bridge Media's website. Opting out of any Internet-based advertising will only work for the browser you are currently using; any additional browsers or devices with which you access LJP Marketing Limited website must be opted out of separately. Some opt-outs may only work if your browser accepts cookies. If you delete cookies, change your browser settings, switch browsers or computers, or use another device, you may be required to opt-out again.
